LADI PARTICIPANT RELEASE, WAIVER AND INDEMNITY AGREEMENT

This will confirm an agreement (the "Agreement") by ______ (the "Participant") for the benefit of **The Los Angeles Debate Intensive LLC** ("LADI") with respect to the San Jose Debate Intensive ("SJDI") for the term **June 24, 2018** to **July 29, 2018**. The terms of this Agreement are as follows:

- 1. Governing Law: This Agreement shall be governed in all respects by the laws of the United States of America and by the laws of the State of California. Each of the parties irrevocably consents to the exclusive personal jurisdiction of the federal and state courts located in California, as applicable, for any matter arising out of or relating to this Agreement, except that in actions seeking to enforce any order or any judgment of such federal or state courts located in California, such personal jurisdiction shall be nonexclusive. A prevailing party in any dispute shall be entitled to an award of attorney fees.
- 2. Acknowledgement of Transportation: The Participant (and his or her parent or legal guardian, if the Participant is a minor) understands that they will be transported by car, bus, or shuttle at various times during SJDI. This includes, but is not limited to, transportation between Mineta San Jose International Airport and San Jose State University on June 24, 2018 and/or July 29, 2018 (or an alternate date and location, if indicated by SJDI/LADI staff) and transportation to and from an activity away from San Jose State University's campus. The Participant (and his or her parent or legal guardian, if the Participant is a minor) further consents for the Participant to participate in any off-campus activities arranged by the LADI/SJDI. The off-campus activity may include, but is not limited to, meals in downtown San Jose and day trips to San Francisco, CA.

Personal Conduct: During travel to and from SJDI and all SJDI/LADI activities (on or off-site), the Participant agrees to follow the SJDI/LADI Personal Conduct Policy requirements, attached hereto as Exhibit A. The Personal Conduct Policy includes the Off-Site Personal Conduct Policy requirements, also attached as Exhibit A. The Participant understands that failure to abide by the Personal Conduct Policy may cause the Participant to be removed from the rest of the SJDI workshop without refund. The Participant further agrees to be subject to any fees for room keys, building access cards, or linens not returned at the end of the program, or for damages to their room or other property of the host venue. The Personal Conduct Policy includes, but is not limited to,

- **a.** Following all federal, state, and local laws;
- **b.** Refraining from any kind of harassment (verbal, sexual, etc) targeting or in the presence of instructors and/or other student participants;
- **c.** Abiding by all rules of the host venue.
- 3. Release of Liability: The Participant (and his or her parent or legal guardian, if the Participant is a minor) shall hold the LADI harmless, defend and indemnify them from any claims arising from the Participant's participation on debate coaching services by LADI/SJDI, housing/boarding at San Jose State University during the SJDI program, and any claims arising from transportation and/or off-site activities. This release includes, but is not limited to, physical injury, mental and emotional grievances, and personal complaints on behalf of students, parents, or instructors. I acknowledge that any activity, including transportation and off-site activities, carries with it risks of injury and damage to not only myself but others as well. As such, I knowingly assume all risks of liability known or unknown relating to my participation in off-site activities and transportation associated with LADI. I further release and hold harmless LADI for any injuries that I may suffer in connection with vehicle travel and/or off-site activities. Such release and indemnity is more fully set forth in Exhibit B attached hereto.

The party agrees that violation of the Personal Conduct Policy will result in immediate termination of services of SJDI/LADI and that the student's fees will NOT be returned or refunded.

Exhibit A Personal Conduct Policy

Participants in the San Jose Debate Intensive ("SJDI") must follow the **Personal Conduct Policy**.

- 1. Participants must, at all times, follow all federal, local, and state laws that are applicable.
- 2. Participants may not harass and/or bully any participants or instructors of the LADI/SJDI. Harassment of a verbal, physical, sexual, or online nature will not be tolerated.
- 3. Participants must abide by all rules of the host venue, including all terms and conditions of the San Jose State University Summer Conference Housing and Dining Services. Participants may not vandalize or damage the property of the host venue. Participants will be subject to any charges assessed by the host venue for damages to their room or other property.
- 4. Participants are responsible for the room keys, building access cards, and linens assigned to them during SJDI/LADI. Keys and key cards must be returned at the end of the program. Lost or damaged room keys will be subject to a \$75 replacement charge and lost or damaged access cards will be subject to a \$25 replacement charge.
- 5. Participants must remain on the premises unless personally escorted off the premises by an instructor for lunch, or for an emergency. In the event of leaving the premises, the Participant must remain with the instructor at all times.
- 6. Participants must refrain from the use of alcohol and controlled substances without prescription while at LADI/SJDI.

During off-site activities, participants in SJDI must follow the additional **Off-Site Personal Conduct Policy** requirements.

- 7. Participants must remain within the general vicinity of the off-campus activity designated by instructors of the LADI/SJDI at all times. If participants are not accompanied by a staff member, they must check in with instructors at regular intervals or when contacted by the staff of the LADI/SJDI. Participants must answer all phone calls and/or text messages from all staff members of the LADI/SJDI.
- 8. When transportation has been scheduled to leave from San Jose State University or a designated off-campus location at a particular time, participants must be present at that location by the designated time.
- 9. Participants must refrain from the use of alcohol and controlled substances without prescription during all off-campus activities.
- 10. Participants must abide by all additional rules and guidelines issued by staff of the LADI/SJDI.

Exhibit B Release of Liability, Indemnity and Covenant Not to Sue

I HEREBY INDEMNIFY, HOLD HARMLESS AND AGREE TO DEFEND THE LOS ANGELES DEBATE INTENSIVE LLC FROM ANY AND ALL EXPENSES INCURRED, CLAIMS MADE, OR LIABILITIES ASSESSED AGAINST THEM, INCLUDING BUT NOT LIMITED TO ATTORNEYS' FEES AND LITIGATION EXPENSES, ARISING OUT OF OR RESULTING FROM, DIRECTLY OR INDIRECTLY, IN WHOLE OR IN PART BY (A) MY ACTIONS OR INACTIONS; (B) MY BREACH OR FAILURE TO ABIDE BY ANY PART OF THIS WAIVER AND RELEASE INCLUDING BUT NOT LIMITED TO MY COVENANT NOT TO SUE; (C) ANY OTHER HARM CAUSED TO ME; AND (D) ANY NEGLIGENT RESCUE OPERATIONS.
